### CREDIT OR DEBIT CARDS NOW ACCEPTED



The Village of Dane accepts debit or credit cards for payments on utility bills, parking tickets, licenses, permits and real estate tax payments. Cards accepted are MasterCard, Visa, American Express and Discover. A service fee is charged for each transaction and paid by the cardholder. This service is available 24 hours a day 7 days a week by phone 1-888-604-7888 or through the internet at [www.GovPayNow.com](http://www.GovPayNow.com). ### CHECK THE LOCATION OF YOUR MAILBOX



Mailboxes that protrude out and over the front of the curb on village streets cause problems during the Winter Snowplow Season. The Village will not be responsible for repairs or replacement of any mailbox that is damaged due to

snow. Please check your mailbox and make adjustments before that white stuff starts to fly.

### PARKING RESTRICTIONS

Winter Parking goes into effect on November 15, 2015. Tickets will be issued as needed. Village Ordinance 495-19 states, "Parking of any motor vehicle is prohibited upon any street within the Village limits between 2:00 a.m. and 6:00 a.m. from November 15 to March 15."



### SNOW REMOVAL

Village Ordinance Chapter 457-10 covers removal of snow from sidewalks. The owner, occupant or person in charge of any parcel or lot which fronts upon or abuts any sidewalk shall keep said sidewalk clear of all snow and ice. In the event of snow accumulating on said sidewalk due to natural means and/or by any other means, said sidewalk shall be cleared of all accumulated snow and/or ice within 24 hours from the time the snow ceases to accumulate on said sidewalk. Sidewalks are to be kept clear of snow and ice to a minimum of four feet in width. In the event that ice has formed on any sidewalk in such a manner that it cannot be removed, the owner, occupant or person in charge of the parcel or lot which fronts upon or adjoins said sidewalk shall keep the sidewalk sprinkled with sand and/or salt to permit safe travel by pedestrians.



### DELINQUENT ACCOUNTS



Anyone with an unpaid special assessment, annual public fire protection invoice or delinquent water/sewer bill will be fined an additional 10% of the balance as of 10/31/2015. If the charges are still unpaid on November 15, 2015, the amount will be placed on the property tax bill. Please contact the Village Clerk to pay the PAST DUE amount.

### TAX BILLS

By State Statute the 2015 tax bills will be in the mail by the third Monday in December.
