 need to be removed from the curb as soon as possible on Trash Collection Day. Trash Containers can be blown around, hit by vehicles, or buried in snow piles if not promptly moved from the curblane. If containers are continually left out at the edge of your property, the Public Works Department will collect them. If your containers are picked up by Public Works, you will be fined and the fee will need to be paid before you are able to claim your containers at the Public Works Garage.

**Please keep your sidewalks clear of snow and ice!**

Whether it is snowing the white fluffy stuff, blowing it around, or raining; it is the property owner's responsibility to clear the full width of the sidewalk adjacent to their property of all snow and ice. Property owners' have 24 hours after a snowfall ends to clear their walkways. In the event that ice has formed on any sidewalk where it can't be removed the walk should be sprinkled with sand or salt to permit safe travel by pedestrians. Village Employees will clear sidewalks at a charge of \$60, when necessary. More information can be found in Chapter 457 of the Village of Dane Ordinances.

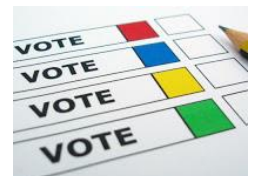
